IN 2019, CHRISTEL HOUSE SERVED 5,340 STUDENTS AND ALUMNI. IT OFFERS A LONGER SCHOOL YEAR AND AN EXTENDED SCHOOL DAY. CHRISTEL HOUSE'S DAILY K-12 ATTENDANCE RATE WAS 96%, AND 94% OF 2018 STUDENTS RETURNED TO SCHOOL IN 2019 (EXCLUDING GRADUATES). IN 2019, 97% OF STUDENTS PASSED GRADUATION EXAMS AND 92% OF GRADUATES WERE CONTINUING STUDIES OR GAINFULLY EMPLOYED.
